# EXAMINING THE IMPACT OF CHINESE MASS ORGANIZATIONS ON ASEAN FOREIGN RELATIONS: A DATA-DRIVEN INVESTIGATION

#### **Abstract:**

By bridging the gap in this area, our study aims to offer valuable theoretical guidance and policy recommendations to enhance decision-making practices in ASEAN foreign affairs.

#### Introduction

"Belt and Road" (2013) has become an important platform for China's opening-up and international cooperation. As an important component of China's social governance, mass organizations are of great practical significance to carry out non-governmental diplomacy to the ten ASEAN countries and to promote the high-quality joint construction of "Belt and Road"[1]. In China, the evidence-based decision-making study on the effectiveness of Belt and Road mass organizations in the foreign affairs service of ASEAN is still in its infancy, while other related studies have yielded fruitful results. "Belt and Road" is a hot issue in international relations and regional cooperation, and the evidence-based research on the effectiveness of ASEAN foreign affairs is of great practical significance. The research adopts a variety of research methods, combined with theoretical analysis and empirical research, with both theoretical support and practical targeted research experience and ability in Belt and Road Co-construction, mass organization, ASEAN foreign affairs service efficiency and evidence-based decision-making, so as to ensure the smooth progress of the research. In conclusion, this study is highly feasible and is expected to provide useful theoretical guidance and policy suggestions for the decision-making practice of foreign affairs services in ASEAN [2].

platform for practical cooperation; not a foreign aid plan, but a joint development initiative of consultation, joint contribution and sharing. Therefore, as the organizational carrier of civil diplomacy, organizations play an important role in Belt and Road construction: first, it can play its organizational advantages to provide talent, technical and financial support for the construction of One Belt and One Road; second, it can play its role as a bridge, strengthen the exchange and cooperation with ASEAN countries, and promote the in-depth development of Belt and Road construction [4]. Zhao Tao (2015) believes that China's strategic concept of jointly building "Belt and Road" has endowed the ancient Silk Road with new connotation of the Times and provided innovative ideas for deepening regional exchanges and cooperation. Li Weili (2016) believes that it is necessary to continuously expand the external extension of its own organization system through the mass organization network, make full use of the characteristics and advantages of mass organizations, and realize the integration and re-reorganization of decentralized social organizations. The current international situation is undergoing a multi-polar development, and mass organizations have played a key role in stabilizing and maintaining the order of social development [5].

The research focuses on the impact of the "Belt and Road" initiative on the efficiency of ASEAN foreign affairs services. Scholars generally believe that the Belt and Road initiative provides new development opportunities for the efficiency of ASEAN foreign affairs services and helps to promote the economic cooperation and regional integration process among ASEAN countries. Chen Huan (2022) believes that under the perspective of the further implementation of the "Belt and Road" initiative, it is urgent and important for China to construct its national image for ASEAN. Tu Qiangnan (2022) believes that the marginal effect of "Belt and Road" initiative on production capacity cooperation is gradually increasing; in the countries along the border with China. By expanding the scale of China's outward direct investment in ASEAN, it will have a certain impact on promoting the manufacturing production capacity cooperation between China and ASEAN and promoting the upgrading of China's manufacturing industry, but the effect is relatively limited.

At home and abroad, the role of Belt and Road organizations is mainly concentrated in economic cooperation and cultural exchanges[6]. There are relatively few evidence-based decision-making studies on the effectiveness of Belt and Road organizations in ASEAN foreign affairs, and the research contents and methods need to be further expanded and improved. In the future research, more attention should be paid to the practical role of mass organizations in Belt and Road construction, and how to improve the evidence-based decision-making ability of mass organizations in the efficiency of foreign affairs services in ASEAN, in order to enrich and expand the research content of theory and practice in Belt and Road construction.

# 2. Academic value and application value

(1) Enriches the theoretical research system of international relations. This study combines the "Belt and Road" joint construction group organization with the effectiveness of ASEAN foreign affairs services, from the perspective of evidence-based decision-making, and helps to enrich and expand the theoretical system of international relations. Therefore, compared with the existing project, this research has a unique perspective, which brings unique unique academic value and application value.

To sum up, the Belt and Road's evidence-based decision-making research on ASEAN foreign affairs service efficiency has important academic value and application value.
